Way to go!

Your doctor has prescribed TEPEZZA and you're ready to take a big step in treating your Thyroid Eye Disease (TED)! Before you can begin treatment, you and your doctor will work together to get your insurance provider to approve TEPEZZA.

TEPEZZA is a specialty medicine that you receive through an intravenous (IV) infusion. Specialty medicines require a few extra steps to get insurance approval and start treatment. It can take up to 90 days from the time your doctor prescribes TEPEZZA until you get your first infusion. This could be shorter or longer, depending on your insurance provider.

This guide will walk you through each phase of the insurance approval process. You'll also learn about services available to help you through the process, and what you can do to help move the approval process along.

So, let's get started!

The 3 phases of the insurance approval process



Phase 1:

Prescription & enrollment

- Prescribed TEPEZZA
- If you haven't already, you can enroll in our patient support program, Amgen By Your Side



Phase 2:

Insurance review

- Amgen By Your Side team is there to discuss insurance coverage with you
- Fill out the Insurance Advocacy Form found on the last page and give to your doctor
- You and your doctor determine the location for your TEPEZZA infusions based on the options available through your insurance provider
- Your doctor submits medical information explaining why TEPEZZA has been prescribed to your insurance provider



Phase 3:

Insurance approval

- Your insurance provider reviews information and in some cases requests your doctor provides additional information
- Your insurance provider determines coverage approval
- Upon approval, you are ready to prepare for treatment!

Once your doctor has prescribed TEPEZZA, they will begin the insurance approval process. Your doctor will provide important information about your condition to your insurance provider, who will begin reviewing your coverage for TEPEZZA. Most doctors will also submit a Patient Enrollment Form to enroll you into Amgen By Your Side, a patient support program.

Enrolling in Amgen By Your Side



Amgen By Your Side is a patient support program designed specifically for you, someone prescribed TEPEZZA. Our dedicated team is your partner, committed to providing nonmedical, personalized support so you can start and continue on treatment as prescribed by your doctor. If you have connected with a Patient Access Liaison (PAL), you are already enrolled in Amgen By Your Side. If you want to enroll in Amgen By Your Side, there is no cost to enroll, and you can join in one of two ways:



Option 1: Sign up through your doctor's office. They can start the enrollment on AmgenByYourSide.com and submit it for you on your behalf. Patient consent will also be required.

Option 2: If you have a prescription for TEPEZZA, call 1-877-305-7704 to get connected. A Patient Access Liaison will help you explore enrollment options.

Once enrollment is complete, your Patient Access Liaison will be your dedicated partner to help you get started and continue on your treatment, as prescribed by your doctor.

Phase 2: Insurance review



Next, your insurance provider, your doctor's office or infusion center, and your Patient Access Liaison (PAL) will work together to confirm the details of your insurance coverage for TEPEZZA. This step is called the Benefits Investigation.



The Benefits Investigation and Summary of Benefits review includes:

- Details of your insurance coverage criteria for TEPEZZA.
- Estimate of your potential out-of-pocket costs to determine the best resource for potentially offsetting treatment-related costs.
- Whether prior authorization is needed from your doctor.



TEPEZZA is an intravenous (IV) medicine you receive through a process called an "infusion." Your doctor and/or insurance provider will work with you to find an infusion center where you will get your TEPEZZA treatment.



Your doctor and infusion center will work together to prepare all the necessary paperwork. This includes the Prior Authorization, if it's needed. **You can help speed up the process by completing the Insurance Advocacy Form and giving it to your doctor.** Once all the paperwork is in order, your doctor will submit it to your insurance provider for you.

Phase 3: Insurance approval



Your insurance provider reviews the information sent over by your doctor and infusion center.



In some cases, your insurance provider may need more information from your doctor before they can approve TEPEZZA. Common reasons include incomplete or missing clinical information. Your Patient Access Liaison (PAL) can help you learn about the steps you can take to keep the process moving.



Once your insurance provider has all the information they need, they will approve coverage of TEPEZZA. That means you can start planning your first infusion. Your PAL is also available to support and educate you through this process.

Remember: the insurance approval process may take up to 90 days, but a decision is reached sooner for many patients.



Rarely, an insurance provider may decide not to cover TEPEZZA. If this happens to you, your PAL can provide options and resources for access to TEPEZZA.

USE

IMPORTANT SAFETY INFORMATION

What is the most important information I should know about TEPEZZA?

Infusion reactions can happen during or within 24 hours after your infusion of TEPEZZA. If you have a reaction while receiving TEPEZZA, your doctor or nurse will slow or stop your infusion and treat your reaction. If you have a severe infusion reaction, your doctor may stop your treatment completely.

Tell your doctor or nurse right away if you have any of these symptoms during or after your treatment with TEPEZZA:

- High blood pressure
- Fast heartbeat
- Redness of the face/Feeling hot
- Difficulty breathing
- Headache
- Muscle pain

TEPEZZA may worsen inflammatory bowel disease (IBD), such as Crohn's disease or ulcerative colitis, even if you don't have a diagnosis of IBD before starting TEPEZZA treatment. Tell your doctor right away if you have worsening IBD symptoms, which may include diarrhea with stomach pain or cramps, blood in your stools, sudden urgency to have a bowel movement, or feeling like you need to have a bowel movement even when there's little or no stool to pass.

TEPEZZA may cause an increase in your blood sugar. Before starting treatment with TEPEZZA, tell your doctor if you are currently being treated for diabetes, know your blood sugar is high, or have been diagnosed with diabetes. It is important for you to take your treatments and follow an appropriate diet for glucose control as prescribed by your doctor.

TEPEZZA may cause severe hearing problems including hearing loss, which in some cases may be permanent. Tell your doctor if you have any signs or symptoms of hearing problems or changes in hearing.

IMPORTANT SAFETY INFORMATION continued

Before receiving TEPEZZA, tell your doctor if you:

- Have inflammatory bowel disease (Crohn's disease or ulcerative colitis).
- Are currently being treated for diabetes, have been diagnosed with diabetes, or know your blood sugar is high.
- Are pregnant or plan to become pregnant. TEPEZZA may harm your unborn baby. Tell your doctor if you become pregnant or suspect you are pregnant during treatment with TEPEZZA.
 - Women who are able to become pregnant should use an effective form of birth control (contraception) prior to starting treatment, during treatment and for at least 6 months after the final dose of TEPEZZA.
- Are breastfeeding or plan to breastfeed. It is not known if TEPEZZA passes into your breast milk. Talk to your doctor about the best ways to feed your baby during treatment with TEPEZZA.
- Tell your doctor about all the medicines you take, including prescription and over-the-counter medicines, vitamins, dietary and herbal supplements. Know the medicines you take. Keep a list of them to show your doctor and pharmacist when you get a new medicine.

What are the possible side effects of TEPEZZA?

The most common side effects of TEPEZZA include muscle cramps or spasms, nausea, hair loss, diarrhea, feeling tired, high blood sugar, hearing problems, taste changes, headache, dry skin, ear discomfort, weight loss, nail problems, and changes in menstruation.

This is not a complete list of all possible side effects. Tell your doctor or treatment team about any side effect you may have.
